Description		PLS 101 është projektuar për t'i prezantuar studentëve lëndën e shkencave politike. Së katërti, lënda do të krahasojë sistemet politike, partitë politike, sistemet zgjedhore dhe do të shpjegojë grupet e interesit.					
Objectives		Politics is often commented on as a necessary evil. But what is politics? What is the impact of politics on society and what is the relationship between politics and governance? What is the impact of politics on the good functioning of institutions? The course will elaborate the above questions in a critical way with the aim of realizing three main objectives: PLS 101 will refine students' understanding and perception of the role of politics. PLS 101 will elaborate on concepts such as power, the state, governance, sovereignty, and legitimacy with a special focus on democracy. The course will introduce students to the main differences between a democratic and non-democratic regime. PLS 101 will explain how political institutions work and how political behavior and institutions interact to create the political product. Therefore, the course is designed to expand students' knowledge of contemporary political issues.
